## **Proceedings of the Executive Body meeting of the New Life Education Trust held on 15th April 2011 at Matrubhaban, Cuttack.**

The meeting started at 11 AM with Mother's Music. Sri Sriballav Panigrahi, President, presided and welcomed the members present in the meeting.

At the beginning, the Secretary explained the reason why all district organisers of the state along with the zonal organisers have been requested to attend the meeting. It was found that 22 district organisers have turned up out of 30 and those who did not attend were Kendujhar, Puri, Khurdha, Raygada, Phulbani, Baud, Balangir & Nuapada. Out of 9 zones except Santi and Aspruha all other zonal co-ordinators were present in the meeting.

Then the proceedings of the last meeting of the Executive Body held at Sri Aurobindo Integral Education Centre, Dera on 13.03.2011 was read out by the Secretary and the action taken was discussed and confirmed.

The Secretary pointed out about the discussion made in the last meet of the Secretaries and Principals held on 16th & 17th April at Khandagiri and the implementation of Right to Free and Compulsory Education in our Schools.

The progress of visit of the Co-ordinators could not be taken up as the required schedule has not been prepared due to many other assignments during the last two months. However, the matter was deferred to the next meeting.

Then the agenda item was taken up. The President narrated about the discussion made with the commissioner, School & Mass Education in her office chamber on 4th May at 12 noon. She had promised all types of helps to our schools but as per the Govt. notification in the newspaper she requested that let all schools first apply in Form No.-1 to the DI for recognition. Soon after all schools apply for recognition, the major problems can be sorted out which need any help or guidance or assistance from the Dept. of School and Mass Education. She also promised for all types of help including finance if asked

prior to the budget with justification. She also agreed to allow our own syllabus and the Text Books for Std. VIII. She did not agree to give any nodal officer and said that she loved to be disturbed and no nodal officer is required to look after the Integral Schools as she herself can be the nodal officer. She said that during June, the review meeting of all districts will be taken up. She requested us to attend the district review meeting when we can place the problems of our schools of respective districts and those can be taken up then & there.

Then Secretary said about the Govt. notification regarding the recognition of the private schools. He said that all schools whether recognised or unrecognised must apply in Form No-1 for recognition near the D.I. of Schools by 31st July 2011.

It was understood that many schools have already applied for recognition to DI/ DPI and at some places, the DIs have already issued recognition orders. But the latest notification of the Govt. says that all schools should apply for recognition afresh in form No.1 by 31 st July 2011. So the Form No.1 was readout by the Secretary and discussed thoroughly. Each word and line were discussed in which almost all members present participated. The form No-1 was printed and each district co-ordinators were issued with the no of forms required for their district.

Then the matter regarding Summer Refresher Training Camp was discussed. It was learnt that 440 teachers have participated in the training programme. Though the no. is encouraging but it was found that about half of the teachers were fresh having experience less than six months. It was therefore decided that teachers having experience more than one year should be sent for training.

Then the issue regarding July tour was discussed and it was re-emphasised that each Integral school must attend the organisational meet of their district with the teachers and members of Study Circles. The schools are also requested to deposit their annual subscription along with Rs.100/- (Rupees one hundred only) for 'Purnata Pathe' (Annual Subscription) to the Trust. Those who are interested to subscribe 'Purnata Pathe' may also deposit Rs. 100/- with the Trust Co-ordinator. The schools should be kept closed for the purpose. Each school should fill up the Information Sheet which is extremely important. The Information sheet has been sent through either the district organiser or by post. In case any school has not received the Information Sheet, they must inform by phone to the Secretary (9437023407) or to the concerned Trust co-ordinator for getting the same immediately.

Regarding opening of Std.VIII, it was decided that each school having up to Std-VII have to open Sid-VIII and apply for recognition from DI of schools

in Form No. 1 and affiliation from New Life Education Trust. However, the Govt have been requested to allow our own syllabus, Courses of Study and Text books for Std-VIII to which they have agreed verbally.

It was decided to open a new account in the joint names of Secretary & Treasurer in Allahbad Bank, Bhubaneswar for transaction of cash in connection with Text Book Publication. It was further decided that the existing account in the name of Secretary & Joint-Secretary (S. Mohanty) should be changed to Secretary & Treasurer immediately.

The next meeting of the Executive Body will be held on 7th August, 2011 at 10 am at Sri Aurobindo Integral Education Centre, Rairakhol in the district of Sambalpur.

After lunch, Sri Mohit Mohan Mohanty, the Educational Adviser of the New Life Education Trust met a small group of the members and discussed further about the Form No-1. However, he also advised that all schools should first apply with whatever available with them as per Form No-1 and after inspection only it can be ascertained the things that are wanting.

The following Sri Aurobindo Integral Education Centres have applied for either fresh affiliation or renewal of affiliation. The members mentioned against each were requested to visit the centre and recommend for consideration.




